WHEREAS, I, **Peter John ELLIOT** of **Pryor House, Froggatt Edge, Calver, Hope Valley, S32 3ZB, England**, have invented certain new and useful improvements in **MONITOR AND/OR OVERLOAD MEANS** for which I have executed an application for Letters Patent of the United States on the 21st day of July, 1998; and

I do hereby covenant and agree, for myself, my heirs and legal representatives, that I will assist said **ASSIGNEE** in the prosecution of the application herein identified; in the making and prosecution of any other applications for Letters Patent that said **ASSIGNEE** may elect to make covering the invention herein identified, as hereinbefore set forth; in vesting in said **ASSIGNEE** like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference which may arise involving said invention, or any application or Letters Patent herein contemplated; and that I will execute and deliver to said **ASSIGNEE** any and all additional papers that may be requested by said **ASSIGNEE** to fully carry out the terms of this assignment.

I do hereby authorize and request my attorneys, **Trexler, Bushnell, Giangiorgi & Blackstone, Ltd.**, of 105 West Adams Street, Chicago, Illinois 60603, to insert here in parentheses (Serial No._09/119,376, filed July 20, 1998) the date and serial number of said application when officially known.
