The Designer warrants in favour of the Assignee that the designs are original and that immediately prior to the execution hereof the rights granted by virtue of this Assignment vested in the Designer and that nothing has been done nor has any event occurred whereby such rights or any of them may be declared void or terminated.
5. The Designer covenants in favour of the Assignee that the Assignee shall have and enjoy quiet possession of the rights granted herein uninterrupted and undisturbed by the Designer or any other party claiming through, under or in trust for the Designer.
6. The Designer further warrants that to the best of the Designer's knowledge and belief the grants granted herein do not infringe the rights of any third party.
