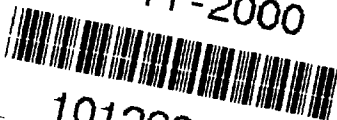

**ASSIGNMENT**

WHEREAS, David A. Wightman, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled VAPOR COMPRESSION SYSTEM AND METHOD, filed on January 12, 1999 with the U.S. Patent and Trademark Office, having U.S. Serial No. 09/228,696;



The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.




