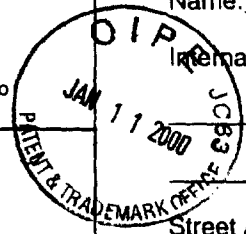

WHEREAS, I, Guglielmo BIAGIOTTI,

 necessary assistance in making application for and obtaining original, divisional, reissued, or  
 extended Letters Patent of the United States or of any and all foreign countries on said invention,  
 and in enforcing any rights or choses in action accruing as a result of such applications or patents,  
 by giving testimony in any proceedings or transactions involving such applications or patents, and  
 by executing preliminary statements and other affidavits, it being understood that the foregoing  
 covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives  
 of assignor and assignee;

AND I request the Commissioner of Patents and Trademarks to issue any Letters Patent of the  
 United States which may be issued for said invention to said assignee,  
 its legal representatives, successors, or  
 assigns, as the sole owner of the entire right, title, and interest in and to said patent and the  
 invention covered thereby.
