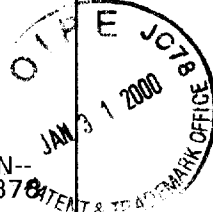

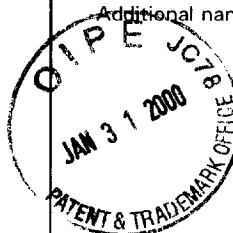

SWITCH ADAPTER TESTING


