## ASSIGNMENT

WHEREAS, Yung-lung Tseng, Min-ying C. Tseng, and Conray C. Tseng, all of 357 Mellow Lane, La Canada, California 91011 are the joint inventors of an invention in a "Gripping Bandage" and jointly filed a patent application in the U.S. Patent and Trademark Office on November 10, 1997, bearing Serial No. 08/966,515 covering their invention (hereinafter the "Invention");

WHEREAS, Conray C. Tseng desires to transfer his undivided one-third interest in the Invention and to the United States Letters Patent to be obtained therefore to the Pao-Luan Chang Irrevocable Trust for Conray Tseng (hereinafter the "Trust").
