TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

TERMINATION AND RELEASE dated as of December 27, 1999, from The Chase Manhattan Bank, a New York banking corporation, located at 270 Park Avenue New York, New York 10017-3954 (the "Secured Party") to Birtcher Medical Systems, Inc., (the "Grantor"), located at 310 Broad Street, Utica, New York 13501.

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of December 31, 1997, among Conmed Corporation and certain of its subsidiaries, including Grantor, the lenders from time to time party thereto (the "Bank Creditors") and the Secured Party, as administrative agent for the Bank Creditors (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Secured Party in certain Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent & Trademark Office on April 6, 1998, at Reel 9187, Frame 0010; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby terminates and releases the Security Interest in the Collateral as follows:

1. **Collateral:** The term "Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature in:

(a) the letters patents of the United States, and all reissues and extensions thereof and all goodwill associated therewith, set forth on Schedule A attached hereto; and

2. **Further Assurances:** The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interests contemplated hereby.
