ASSIGNMENT

We, **Richard J. Williamson**, citizens of the United States of America residing respectively at **Mitchell E. Further, Assignors agree to communicate to the Assignee, or its representatives, known facts relating to said improvements, testify in any legal proceedings, sign all lawful papers, execute all continuations, divisions, reissues, substitutions and extensions, execute all necessary assignment papers to cause any and all Patents or Industrial Design Registrations to be issued to the Assignee and its successors and assigns in order for the Assignee to obtain and enforce proper protection for said improvements in the United States of America and in any and all foreign countries.
