ASSIGNMENT

WHEREAS, David K. Foote, Hideki Komori, Bharath Rangarajan and Fei Wang, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled PROCESS FOR FABRICATING A BIT-LINE USING BURIED DIFFUSION ISOLATION, executed by Assignors on the same date as this Assignment;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.

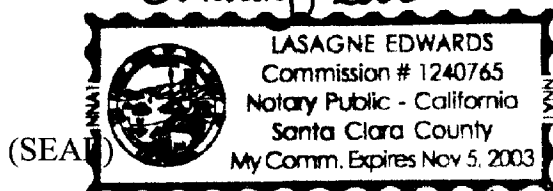
