ASSIGNMENT

WHEREAS, I, MARK HUNTLEY, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **DRIP IRRIGATION HOSE WITH EMITTERS HAVING DIFFERENT DISCHARGE RATES**, filed **November 19, 1999**, Application No. **09/443,561**.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;



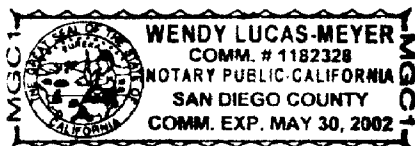


