

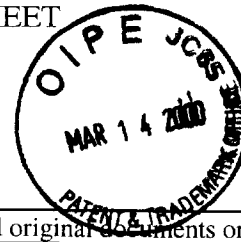

ASSIGNMENT

WHEREAS, Jan ROXBERGH, (hereinafter ASSIGNORS) of Transformatorvägen 4, Sollentuna, SWEDEN, have invented a certain improvement in DOWNLINK POWER CONTROL AT SOFT HANDOVER for which a so-entitled application for Letters Patent of the United States was filed in the United States Patent and Trademark Office on December 20, 1999 under Serial No. 09/466,916;

WHEREAS, Telefonaktiebolaget LM Ericsson (hereinafter ASSIGNEE), a corporation of the Country of Sweden, having an office and place of business at S-126 25, Stockholm, Sweden, is desirous of acquiring an interest therein;

States of America adheres, and hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent to ASSIGNEE, for its interest as ASSIGNEE, for the sole use and behoof of ASSIGNEE, its successors, assigns, and legal representatives.

And, ASSIGNORS hereby agree to transfer a like interest upon request of said ASSIGNEE, its successors, assigns, and legal representatives, and without further remuneration, in and to any improvements, and applications for patents based thereon, growing out of or related to the said invention; and to execute any papers by ASSIGNEE, its successors, assigns, and legal representatives, deemed essential to ASSIGNEE'S full protection and title in and to the invention hereby transferred.

Agreeing, further, upon request of ASSIGNEE, and without further remuneration, to execute any and all papers desired by ASSIGNEE, for the filing and granting of foreign applications and the perfecting of title thereto in ASSIGNEE.
