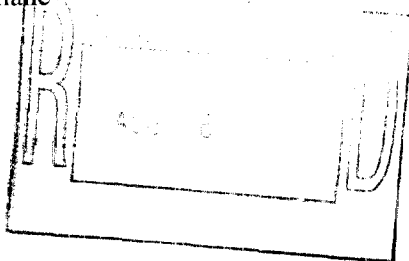

ASSIGNMENT

WHEREAS, we, Mengistu Yemane-Berhane, of Beaverton, County of Washington, State of Oregon, and Bruce L. 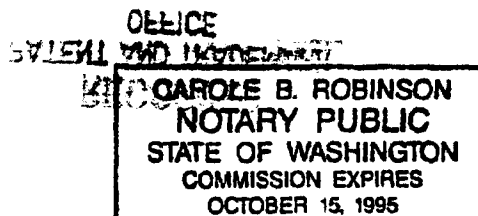
