ASSIGNMENT

WHEREAS, WE, Douglas B. McCreery, Leo A. Bullara and Stephen H. Waldron, residing at 1498 N. Sinaloa Street, Pasadena, California 91104, 704 E. Kirkwall Road, Glendora, California 91740 and 566 Avocado Place, Camarillo, California 93010, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **ELECTRODE INSERTION TOOL**, and filed on October 27, 1999.

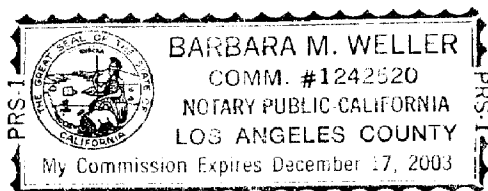

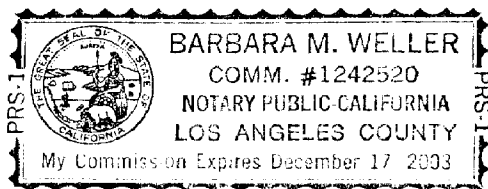

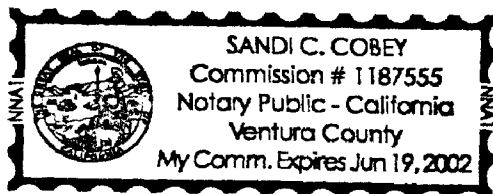
