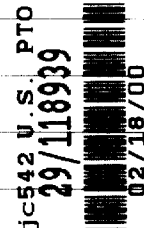

WHEREAS, I, ANTHONY J. GOVERNO, have invented a new, original and ornamental design for


MASONRY SAW
