We, the undersigned

Hereby declare that

We are the true and first inventors of an invention entitled **THERMAL IMAGING PROCESS AND PRODUCTS USING IMAGE RIGIDIFICATION** which is disclosed in United States Patent Application No. **09/419,680** filed on **OCTOBER 15, 1999** (and which is identified as Case Number **PR0013**).

For valuable consideration, the receipt and adequacy of which is hereby acknowledged and in fulfillment of our pre-existing obligation of assignment, we hereby:

I. Sell, assign, and transfer unto **E. II. Agree, whenever requested, to communicate to said assignee, its successors, assigns, and legal representatives, any facts known to us respecting said rights, to testify in any legal proceeding respecting said rights, to execute all applications, papers or instruments necessary or required by said assignee, its successors, assigns and legal representatives, to carry into effect any of the provisions of this instrument, and generally to do everything possible to aid said assignee, its successors, assigns, and legal representatives to obtain and enforce proper patent protection for said inventions in any and all countries.
