AND I HEREBY COVENANT AND AGREE that I will execute or procure any further necessary assurance of the title to the said invention and Letters Patent and that I will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers that may be necessary or desirable to perfect the title to said invention or any Letters Patent which may be granted therefor to the Assignee, its successors, assigns, or other legal representatives and that I will at any time upon the request and at the expense of the Assignee testify in any legal proceeding, sign all lawful papers, execute any additional divisional, substituting, continuing or reissue applications for patents for said invention or any part or parts thereof, make all rightful oaths and generally do all lawful acts to aid the Assignee, its successors, assigns or other legal representatives to obtain and enforce patent protection in said invention in all countries without further compensation but at the expense of the Assignee, its successors, assigns or other legal representatives.


