ASSIGNMENT AND AGREEMENT

For value received, we, Edwin Frank Barry of the City of Cary, State of North Carolina; and Edward A. We request that any and all patents for said inventions be issued to Billions of Operations Per Second, Inc. in the United States and to Billions of Operations Per Second, Inc. in all countries foreign to the United States, or to such nominees as it may designate.
