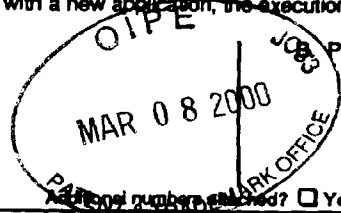

WHEREAS, We, Ingo Ullerich, a citizen of Germany, residing at Parkstrasse 19, 50968 Koeln, Germany and Oliver Hehemann, residing at Kastanienallee 9, 50968 Koeln, Germany have made a certain new and useful invention as set forth in an application for United States Letters Patent entitled PORTABLE PARLOR GAME which was filed in the United States Patent Office on June 1, 1999 under Serial No. 09/308,999.

AND WHEREAS, Franz Josef Paus, a citizen of Germany, residing at Benfleetstrasse 9a, 50858 Koeln, Germany desires to acquire a one hundred percent (100%) undivided interest in and to all rights, title and interest of inventor's Oliver Hehemann rights, title and interest in and to any and all Letters Patent of the United States which may be obtained therefor;

UPON SAID CONSIDERATION, I, Oliver Hehemann, hereby agree with said assignee, Franz Joseph Paus, that I will not execute any writing or do any act whatsoever conflicting with these presents, and that I will, at any time upon request, without further or additional consideration, but at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional reissue or extended Letters Patents of the United States on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of assignor and assignee;

AND FURTHER, that I, Ingo Ullerich, by my signature and execution hereinafter acknowledge the legal significance of and consent to this assignment of the undivided one hundred percent (100%) rights, title and interest of Oliver Hehemann to Franz Joseph Paus as assignee.
