IN CONSIDERATION of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, I: **Juan Carlos Carne CORREA**, residing at Av. I hereby authorize and request the United States Commissioner of Patents and Trademarks and the issuing authorities in other countries to issue all Letters Patent maturing from said application to said CARRIER CORPORATION, as Assignee.

AND, I hereby covenant and agree that I shall at any time, upon request, without further compensation, testify in any interference proceeding, execute all divisional, continuing or reissue applications, make all rightful oaths and generally execute and deliver any and all papers or instruments that may be necessary or desirable to secure said Assignee the full enjoyment of the rights and properties herein conveyed or intended to be conveyed.
