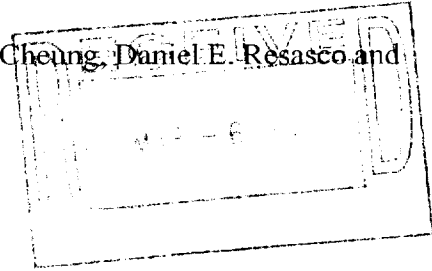

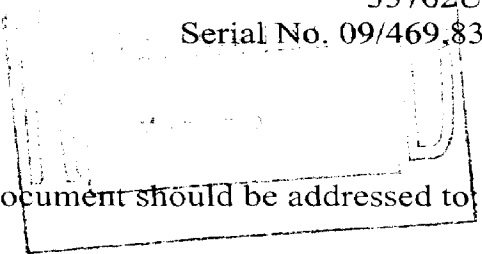

and WHEREAS, Phillips Petroleum Company, a corporation of Delaware, is desirous of acquiring an interest in said invention,




