RELEASE OF PATENT SECURITY AGREEMENT (U.S. REGISTRY)

This Release of Patent Security Agreement ("Release") is made by LASALLE BANK NATIONAL ASSOCIATION, a national banking association, (the "Bank"), in connection with the Guaranty (as hereinafter defined). Terms not otherwise defined herein shall have the meanings given in the Guaranty.

WHEREAS, the Bank extended certain financial accommodations to Advance Dial Company (the "Borrower") pursuant to a certain Amended and Restated Loan and Security Agreement between the Bank and Borrower dated as of November 4, 1994, as amended through and including the date hereof, (the "Loan Agreement"); and

WHEREAS, in connection with the extension of such financial accommodations pursuant to the Loan Agreement, the Bank required the execution and delivery by Summit Coating Technologies LLC, an Illinois limited liability company ("Pledgor") of a Corporate Guaranty dated as of August 31, 1998 (the "Guaranty"). Pursuant to the Guaranty, the Bank acquired a security interest in Borrower's patent rights pursuant to the Patent Security Agreement (U.S. Registry) dated as of August 31, 1998 between Bank and Pledgor (the "Security Agreement"). A copy of the Security Agreement was filed with the United States Patent and Trademark Office ("U.S. PTO") on September 11, 1998 and recorded on U.S. PTO Reel/Frame 9443/0285.

WHEREAS, the Borrower has satisfied all its obligations under the Loan Agreement and Bank has agreed to release the security interest granted by Pledgor to Bank under the Security Agreement.

NOW, THEREFORE, in consideration of the Borrower's satisfaction of its obligations under the Loan Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby agrees as follows:

Release of Security Interest. Bank hereby releases its security interest in and lien upon the Patent Rights (as defined in the Security Agreement). The Bank shall cause a copy of this Release to be filed with the U.S. PTO.

IN WITNESS WHEREOF, Bank has caused this document to be executed as of the 8th day of March, 2000.
