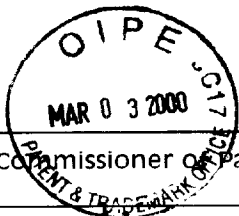

(a) for which an application for a United States patent was filed on March 15, 1999, Application No. 09/254,839,


