## ASSIGNMENT

WHEREAS, Toshihiro Kikuchi, Yoshihiro Someno, Toshio Hirai, Yoshiyuki Kawazoe and Hiroshi Mizuseki, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled A Method for Producing Multilayered Optical Filters Using a Genetic Algorithm and a Method for Operating the Genetic Algorithm, executed by Assignors on the same date as this Assignment;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
