DEED OF ASSIGNMENT OF PATENTS

This ASSIGNMENT (this "Agreement"), dated as of December 15, 1999 (the "Effective Date") is from Uniroyal Chemical Company, Inc. ("Assignor") to CK Holding Corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of all right, title and interest in and to the patents and patent applications described on Schedule A (the "Patents") attached hereto; and

WHEREAS, Assignee desires to transfer the Patents to Assignee as a capital contribution made in accordance with certain corporate resolutions of Assignor.

1. Assignment. Assignor hereby assigns and transfers unto Assignee, its successors, heirs and assigns all right, title and interest in and to the Patents, including without limitation, the right to any continuations, divisionals, reissues or reexaminations thereof, the right to prosecute any applications therefor, the right to have any continuations, divisionals, reissues or reexaminations issue in the name of the Assignee, and the right to sue for past and future infringement.
2. Further Assurances. Assignor will execute any and all additional documents that may be reasonably necessary to perfect the transfer of rights set forth herein.
3. Binding Provisions. This Agreement is binding upon, and inures to the benefit of, the parties hereto and their respective heirs, executors, legal representatives, successors, and permitted assigns.
4. Governing Law. All questions concerning the construction, validity and interpretation of this Agreement and the performance of the obligations imposed by this Agreement shall be governed by the internal law, not the law of conflicts, of the State of Connecticut.
