- 1) In consideration of the sum of £33,442.52 (thirty-three thousand four hundred and forty-two pounds fifty-two pence) (excluding VAT) paid by the Assignee to the Assignor (the receipt of which is hereby acknowledged) the Assignor hereby **CONFIRMS** and **ASSIGNS** with full title guarantee to the Assignee all its right title and interest in and to the IPR **AND** the full and exclusive benefit thereof **TOGETHER WITH** all the rights powers privileges and immunities arising or accruing therefrom (including all rights of action in respect of any infringement of the IPR which may have occurred prior to the date hereof) **TOGETHER WITH** all its rights to apply for and obtain protection in respect of the IPR in all countries of the world (including for the avoidance of doubt the right to claim priority from any application for such protection) to the intent that the grant of any such protection shall be in the name of and shall vest in the Assignee **TO HOLD** the same unto the Assignee absolutely
- 2) At the request and cost of the Assignee the Assignor will execute all such documents and do all such acts as may be necessary or proper to enable the full benefit of the rights hereby assigned to be vested in and enjoyed by the Assignee

IT IS HEREBY CERTIFIED that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the considerations exceeds £60,000 (sixty thousand pounds)


