AND I, **Michael WEISS**, hereby agree to execute, upon request, any and all further papers which may be necessary or desirable to enable the said **MITEL CORPORATION**, its successors and assigns, to file and prosecute said application, and any and all substitutes, divisions, or continuations thereof, and any and all reissues of the Letters Patent granted upon said application, or upon any substitutes, divisions, or continuations thereof, and any and all applications for foreign Letters Patent on said invention; and I, **Michael WEISS**, further agree to execute any all

further papers which may be necessary or desirable to vest or perfect the title of **MITEL CORPORATION**, its successors and assigns, in and to said application and the inventions therein disclosed, and in and to any and all Letters Patent and reissues thereof, both United States and foreign, which may be granted upon said application, and any substitutes, divisions, or continuations thereof, and upon any foreign applications.
