NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) to ARCOTECH SOUTHWEST, INC. in hand paid by MARY FRANCES SHERLOCK and for other good and valuable considerations, the receipt of which is hereby acknowledged, ARCOTECH SOUTHWEST, INC. hereby sells, assigns, transfers and sets over to MARY FRANCES SHERLOCK, all right, title and interest in and to the said invention throughout the world, and said application for U.S. Letters Patent, and any and all divisions, continuations, reexaminations and reissues thereof, and any and all Letters Patent of the United States and foreign countries which may be granted therefor, the same to be held and enjoyed by MARY FRANCES SHERLOCK for her own use and benefit, and for the use and benefit of her successors, assigns, or other legal representatives, to the end of the term or terms for which said Letters Patent of the United States or foreign countries are or may be granted, reexamined or reissued, as fully and entirely as the same would have been held and enjoyed by ARCOTECH SOUTHWEST, INC. if this assignment and sale had not been made.

And ARCOTECH SOUTHWEST, INC. hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said invention or resulting from said application and from any and all divisions, continuations, and reissues thereof, to MARY FRANCES SHERLOCK, as assignee of ARCOTECH SOUTHWEST, INC.'s entire interest, and hereby covenant that ARCOTECH SOUTHWEST, INC. has the full right to convey the entire interest herein assigned, and that ARCOTECH SOUTHWEST, INC. has not executed and will not execute any agreement in conflict herewith.

And ARCOTECH SOUTHWEST, INC. further hereby covenants and agrees that ARCOTECH SOUTHWEST, INC. will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention and to such Letters Patent as may be granted therefor, to MARY FRANCES SHERLOCK, her successors, assigns, or other legal representatives and that if MARY FRANCES SHERLOCK, her successors, assigns or other legal representatives shall desire to file any divisional or continuation applications or to secure a reexamination or reissue of such Letters Patent, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation application, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, his/her successors, or other legal representatives.

And ARCOTECH SOUTHWEST, INC. does further covenant and agree that ARCOTECH SOUTHWEST, INC. will, at any time upon request, communicate to MARY FRANCES SHERLOCK, her successors, assigns or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to ARCOTECH SOUTHWEST, INC., and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, his/her successors, or other legal representatives.
