## Assignment

WHEREAS, Wilhelmus J. QUAX, a Dutch citizen, residing at Voorschoten, The Netherlands, invented a new and useful invention entitled Increasing Production of Proteins in Gram-Positive Microorganisms for which an application for United States Letters Patent was filed, national phase of PCT/US98/14786, under Serial Number 09/46,844; and

Such cooperation by said inventors shall include prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers and other assistance, all to the extent deemed necessary or desirable by said Genencor International, Inc. for (a) perfecting the right, title and interest herein conveyed, (b) prosecuting any of said applications, (c) filing and prosecuting applications for reissuance of any said patents, (d) interference or other priority proceedings involving said invention, and (e) legal proceedings involving said invention and any applications therefor and any patents granted thereon, including without limitation, opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions, provided, however, that the expense incurred by said inventors in providing such cooperation shall be paid for by said Genencor International, Inc.

The terms and covenants of this Assignment shall inure to the benefit of said Genencor International, Inc., its successors, assigns and other legal representatives, and shall be binding upon said inventors, their respective heirs, legal representatives and assigns.

Said inventors hereby warrant and represent that they have not entered and will not enter into any assignment, contract or understanding in conflict herewith.
