## ASSIGNMENT OF PATENTS

WHEREAS, Anthony Kushigian, a deceased individual, formerly a resident of Henderson County, North Carolina, is a named inventor in U.S. Patents 4,393,624, titled THREAD GRINDER; 4,484,931, titled THREAD GRINDER; and 4,559,919, titled GRINDING WHEEL PROFILER (hereinafter referred to as the "Patents");

WHEREAS, Anthony Kushigian made the inventions described and claimed in the Patents while he was President and a substantial stockholder of Normac, Incorporated, a Michigan corporation, having a principal place of business at 340 Airport Road, Arden, North Carolina 28704 ("Normac");

Wood, Jr., Co-Executors of his Estate and acting as his legal representatives, hereby sells, assigns and transfers to Normac, his entire right, title and interest of Anthony Kushigian in and to the Patents, and the inventions disclosed and claimed therein, including the right to sue for and collect damages by reason of past infringement.
