**ASSIGNMENT**

**WHEREAS, WE, ANTHONY ROSE, ANDREW D. DAVIE, AND ALEXIS VUILLEMIN,** residing at 81a Drumalbyn Road, Bellevue Hill NSW 2023 Australia; 13 Altona Avenue, Forestville NSW 2087 Australia; and Flat 6, 95 Ramsgate Avenue, Bondi NSW 2026 Australia, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **SYSTEM AND METHOD FOR OPTIMIZING 3D ANIMATION AND TEXTURES** filed December 23, 1999, Application No. 09/471,722.
