(f) any and all applications for Design Letters Patent upon said invention which may hereafter be filed in any and all countries foreign to the United States of America;


(g) any and all refilings, divisions and continuations of said foreign-filed applications;

(h) any and all Design Letters Patent of countries foreign to the United States of America which may issue from the said foreign-filed applications, refilings, divisions and continuations; and


(i) any and all extensions of, and additions to, said Design Letters Patent of countries foreign to the United States of America.
