WHEREAS, WE, Corinne M. Zemla And Greg M. 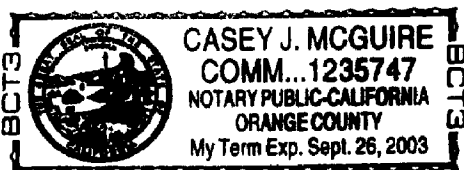
