WHEREAS, said assignors have invented certain new and useful improvements in TARGET CELL-SPECIFIC ADENOVIRAL VECTORS CONTAINING E3 AND METHODS OF USE THEREOF, set forth in an application for Letters Patent of the United States, having an oath or declaration executed on even date herewith; bearing Serial No. 09/474,699 and filed on December 29, 1999; and
