The name of this corporation is BrightLink Networks, Inc.

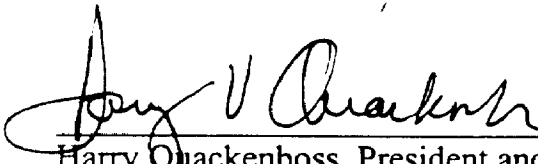
3. The foregoing Certificate of Amendment to the Amended and restated Articles of Incorporation has been duly approved by the Board of Directors of this corporation in accordance with Section 905(b) of the Corporations Code.

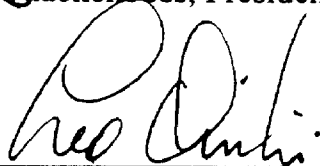

The foregoing Certificate of Amendment to the Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders of this corporation in accordance with Section 902 and 903 of the Corporations Code. The total number of outstanding shares of the corporation is 6,760,959 shares of Common Stock, 3,442,600 shares of Series A Preferred Stock and 6,718,371 shares of Series B Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The vote required was more than

50% of the outstanding shares of Common Stock, Series A Preferred Stock and Series B Preferred Stock voting as a class.

We further declare under penalty of perjury that the matters set forth in the foregoing Certificate are true and correct of our own knowledge.
