## ASSIGNMENT

WHEREAS, I, SOHAIL MIRZA (hereinafter "ASSIGNOR"), having a Post Office address of 5519 159th Place SE, Bellevue, Washington 98006, has made a new and useful INVENTION relating to a "METHOD AND APPARATUS FOR FORMING A CAVITY IN SOFT TISSUE OR BONE", and on March 21, 2000, filed U.S. application Serial No. 09/532,511 (hereinafter "APPLICATION") for a United States Letters Patent (hereinafter "PATENT").

The assigned INVENTION, APPLICATION and any and all Letters PATENT, both foreign and domestic, are to be held and enjoyed by ASSIGNEE for the use and benefit of ASSIGNEE and of ASSIGNEE's legal representatives, successors and assigns, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had this Assignment and Sale not been made; and, I hereby authorize the request the Commissioner of Patents and Trademarks to issue the Letters Patent to the ASSIGNEE.

ASSIGNOR also agrees that this Assignment includes ASSIGNOR'S Proprietary Rights under the International Convention with respect to any and all corresponding foreign applications

that may or shall be filed in any country that is a signatory thereto and a member of the union there defined within the Convention.

ASSIGNOR further agrees that no assignment, sale, agreement or incumbrance has been or will be entered into which would conflict with this Assignment and Sale.

ASSIGNOR further agrees that he will, on request by ASSIGNEE, but at ASSIGNEES expense, promptly provide ASSIGNEE with all pertinent facts and documents relating to the INVENTION, the APPLICATION, or any continuation, divisional, renewal, substitute or reissue thereof, and said Letters PATENT, both foreign and domestic, as may be known and accessible to ASSIGNOR; and that ASSIGNOR will testify on behalf of ASSIGNEE in any interference, opposition or litigation related to the INVENTION, APPLICATION or PATENT, and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain and/or enforce said INVENTION, APPLICATION and PATENT, both foreign and domestic, which may be necessary or desirable to carry out the purposes of this Assignment.
