PATENT SECURITY AGREEMENT**

PATENT SECURITY AGREEMENT, dated as of April 24, 2000 is entered into by and between **VUTEK INC.**, a Delaware corporation ("**Grantor**") and **GENERAL ELECTRIC CAPITAL CORPORATION**, a New York corporation, for itself and in its capacity as Senior Agent for Senior Lenders ("**Senior Agent**").

WHEREAS, pursuant to that certain Credit Agreement dated as of the date hereof among Grantor, as borrower, Senior Agent, the other Persons who are Credit Parties, GECC Capital Markets Group, Inc. and the financial institutions listed therein as Lenders (as it may be amended, restated, supplemented or otherwise modified and in effect from time to time, the "**Credit Agreement**"), the Senior Lenders agreed to make available to Grantor, upon the terms and conditions thereof, certain senior revolving and term credit facilities of up to \$115,000,000 in the aggregate;

WHEREAS, Senior Agent and Senior Lenders are willing to make the Loans to be made by Senior Lenders as provided for in the Credit Agreement, but only upon the condition, among others, that Grantor shall have executed and delivered to Senior Agent, for itself and the ratable benefit of Senior Lenders, that certain Security Agreement dated as of the date herewith (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "**Security Agreement**");

WHEREAS, pursuant to the Security Agreement, Grantor is required to execute and deliver to Senior Agent, for itself and the ratable benefit of Senior Lenders, this Patent Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:


1. **Defined Terms.** All capitalized terms used but not otherwise defined herein have the meanings given to them in Annex A to the Credit Agreement.
2. **Grant of Security Interest in Patent Collateral.** To secure the payment of the Senior Obligations, Grantor hereby grants to Senior Agent, on behalf of itself and Senior Lenders, a continuing first priority security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "**Patent Collateral**"):
 - (a) all its Patents and Patent Licenses to which Grantor is a party including those referred to on Schedule I hereto;

- (b) all reissues, continuations or extensions of the foregoing; and
- (c) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement or dilution of any Patent or any Patent licensed under any Patent License.

3. **Security Agreement.** The security interests granted pursuant to this Patent Security Agreement are granted in conjunction with the security interests granted to Senior Agent, on behalf of itself and Senior Lenders, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Senior Agent with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


IN WITNESS WHEREOF, Grantor has caused this Patent Security Agreement to be executed and delivered by its duly authorized officer as of the date first set forth above.
