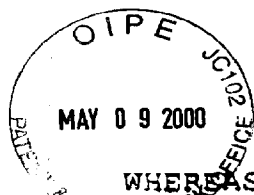

ASSIGNOR hereby acknowledges that on December 10, 1999 ASSIGNOR sold, assigned, transferred, and conveyed unto ASSIGNEE their entire right, title, and interest in and to all of the Patents and Patent Applications and inventions described and claimed therein, and any and all patents that may be granted therefor in the United States its territories and possessions and all foreign countries and any continuations, divisions, renewals, substitutes and/or reissues thereof, including the right to claim priority under any applicable provisions of the International Convention and the Patent Cooperation Treaty and to all Letters Patent or similar legal protection in the United States and its territorial possessions and in any and all foreign countries to be obtained for the inventions described and claimed in said Patents and/or Patent Applications and/or any continuations, divisions, renewals, substitutes, and/or reissues thereof or any legal equivalents thereof in any foreign country for the full term or terms for which the same may be granted.

2. ASSIGNOR hereby assigns to ASSIGNEE all claims for past damages by reason of past infringement of any of the Patents and/or Patent Applications with the right to sue for and collect same for its own use and behalf and for the use and behalf of the ASSIGNEE's successors, assigns and other legal representatives.

3. ASSIGNOR covenants and agrees that at the request of the ASSIGNEE they will promptly take all action deemed necessary by the ASSIGNOR to evidence, maintain, defend and/or perfect the ownership of the Patents and Patent Applications.

4. The terms, covenants, and provisions of this Assignment shall inure to the benefit of the ASSIGNEE, its successors, assigns, and other legal representatives, and shall be binding upon ASSIGNOR, their successors, assigns and other legal representatives.

5. ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

6. ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said Patents and Patent Applications, said inventions described and/or claimed in said Patents and Patent Applications and said Letters Patent and legal equivalents in the United States, its territories and possessions and/or in foreign countries as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said Patents and Patent Applications, said inventions described and/or claimed in said Patents and Patent Applications and said Letters Patent and said equivalents thereof in any United States, its territories and possession and/or in foreign countries which may be necessary or desirable to carry out the purposes thereof.
