ASSIGNMENT OF PATENT APPLICATION

WHEREAS, We, Joseph L. Levasseur and Mark H. Leibu (hereinafter ASSIGNORS), are both United States citizens and have invented new and useful improvements in a coin detection device for which we have filed an application for Letters Patent of the United States, the application being entitled COIN DETECTION DEVICE and having been filed in the U.S. Patent and Trademark Office (USPTO) on February 10, 2000, and having been assigned Serial No. 09/501,948 by the USPTO, and being further identified as Haverstock, Garrett & Roberts LLP Docket Number 3498;

WHEREAS, Coin Acceptors, Inc., (hereinafter COINCO) a Missouri Corporation having a place of business at 300 Hunter Avenue, St. Louis, Missouri 63124, is desirous of acquiring the entire interest in and to the invention as disclosed in the application and in and to any Letters Patent to be obtained therefor;

ASSIGNORS further covenant that we or our representatives will, upon request but without expense to us, do all lawful acts necessary to enable COINCO to obtain and maintain full benefits from the rights and interests herein assigned. This Assignment shall be binding on the successors and assigns of ASSIGNORS and shall inure to the benefit and successors and assigns of COINCO.
