ASSIGNMENT

WHEREAS, Kaoru Soeta, Hiroki Oba and Tatsuaki Kawase

hereinafter called the "Assignors", have made the invention described in the United States patent application entitled Coordinate Input Device Capable of Inputting  
Z-Coordinate of Image Object,

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
