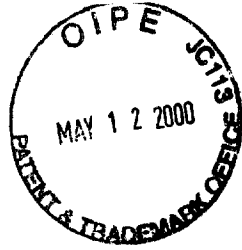



ASSIGNMENT

WHEREAS, I, KURT J. HUNTSBERGER, of Chaffee, county of Wyoming, state of New York, have invented certain improvements in a CHILDREN'S RIDE-ON VEHICLE (design), for which an application for Letters Patent of the United States was filed on February 7, 2000 and given Serial No. 29/118,443; and

Further, I agree that I will communicate to the said MATTEL, INC. or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all related, divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to MATTEL, INC., make all rightful oaths and generally do everything possible to aid MATEL, INC., its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
