

ASSIGNMENT AND AGREEMENT


For value received, I, Chao Wang, of Syracuse in the State of New York, hereby sell, assign and transfer to Cryomech, Inc., a New York Corporation having an office at 113 Falso Drive, Syracuse, New York 13211, and its successors, assigns and legal representatives (hereinafter referred to as the "Assignee"), the entire right, title and interest, for the United States of America, in and to certain inventions related to the PULSE-TUBE CRYOREFRIGERATION APPARATUS USING AN INTEGRATED BUFFER VOLUME described in an application for Letters Patent of the United States, executed by me of even date here with, and all the rights and privileges in said application and under any and all Letters Patent that may be granted in the United States for said inventions; and I also concurrently hereby sell, assign and transfer to Assignee the entire right, title and interest in and to said inventions for all countries foreign to the United States, including all rights of priority arising from the application aforesaid, and all the rights and privileges under any and all forms of protection, including Letters Patent, that may be granted in said countries foreign to the United States for said inventions.

I request that any and all patents for said inventions be issued to Assignee in the United States and in all countries foreign to the United States, or to such nominees as Assignee may designate.
