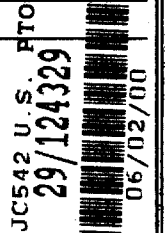

AND I, the said JOËL LEROLLE, do hereby authorize and request the Commissioner of Patents and Trademarks to issue the said Letters Patent of the United States to said LANCOME PARFUMS ET BEAUTE & CIE, as the assignee of the entire right, title and interest in and to the same, for the sole use and benefit of said LANCOME PARFUMS ET BEAUTE & CIE, its successors and assigns;

AND I, the said JOËL LEROLLE, for the considerations aforesaid, do hereby covenant and agree to and with said LANCOME PARFUMS ET BEAUTE & CIE, its successors and assigns, that we have the full power to make this assignment, and that the rights assigned are not encumbered by any grant, license or right heretofore given, and that I, my executor or administrator, shall and will do all lawful acts and things and make, execute and deliver without further compensation, any and all other instruments in writing, further applications, papers, affidavits, powers of attorney, assignments, and other documents which, in the opinion of counsel for said LANCOME PARFUMS ET BEAUTE & CIE, its successors and assigns, may be required or necessary more effectively to secure to and vest in said LANCOME PARFUMS ET BEAUTE & CIE, its successors and assigns, the entire right, title and interest in and to said design and improvements, applications, Design Letters Patent, Design Registrations, rights, titles, benefits, privileges, and advantages hereby sold, assigned, transferred and conveyed.


