ASSIGNMENT

WHEREAS I, Martin Feldman , a citizen of the United States of America, residing at 2811 Ormond Avenue, Baton Rouge, Louisiana 70820; having made an invention in "Adaptive Lithography Membrane Masks," a patent application for which I have executed on even date herewith (attorney file no. necessary by the said Board of Supervisors of Louisiana State University and Agricultural and Mechanical College, its successors, assigns, and nominees, fully to secure its interest as aforesaid and to obtain or maintain Letters Patent in any and all countries;

And I do hereby authorize the Commissioner of Patents and Trademarks, and any foreign counterpart to the Commissioner, to issue any and all Letters Patent which may be granted upon any of the said applications, to the said Board of Supervisors of Louisiana State University and Agricultural and Mechanical College as the assignee of the entire interest therein.


