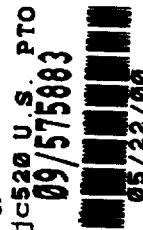

ASSIGNMENT AND AGREEMENT




