ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, we, KARTHIKEYAN RAMASAMY, PRASAD MANIKARAO DESHPANDE, AMIT SHUKLA, and JEFFREY F. NAUGHTON, residing at 12 Sayer Court #66, Madison, Wisconsin 53717, 1622 Monroe Street, Apt. C, Madison, Wisconsin 53711, 6301 Offshore Drive, Apt. 214, Madison, Wisconsin 53705, and 7506 Red Fox Trail, Madison, Wisconsin 53717, respectively, have invented certain new and useful improvements in EFFICIENT EXCEPTION HANDLING DURING ACCESS PLAN EXECUTION IN AN ON-LINE ANALYTIC PROCESSING SYSTEM, Docket No. 8796, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and

Further, we agree that we will communicate to said NCR Corporation, or its representatives, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said NCR Corporation, make all rightful oaths and generally to do everything possible to aid said NCR Corporation, its successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
