WHEREAS, JOSEPH S. STAM, residing in Holland, Michigan, USA, JON H. BECHTEL, residing in Holland, Michigan, USA, SPENCER D. REESE, residing in Fort Wayne, Indiana, USA, JOHN K. ROBERTS, residing in East Grand Rapids, Michigan, USA, WILLIAM L. TONAR, residing in Holland, Michigan, USA and G.
