

ASSIGNMENT

WHEREAS, I, **Erle L. Plunkett**, a United States citizen, residing at 54 Clubhouse Drive, Lockwood Folly, Supply, North Carolina 28462, am the inventor of U.S. Patent No. 5,779,813, entitled "**METHOD AND APPARATUS FOR DECONTAMINATION OF POLY CHLORINATED BIPHENYL CONTAMINATED SOIL**" and issued on **July 14, 1998** ("Patent").

Armstrong, Jr.**, his successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant and agree that I will communicate to the said **Harold M. Armstrong, Jr.**, his successors, legal representatives and assigns, any facts known to me respecting the Patent and any improvements and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Harold M. Armstrong, Jr.**, his successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
