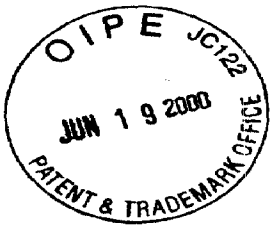
ASSIGNMENT AND AGREEMENT
