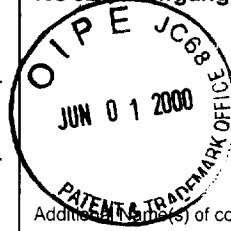


ASSIGNMENT OF PATENT
