ASSIGNMENT OF PATENT

THIS AGREEMENT entered into on <sup>May</sup> ~~March~~ 12, 2000, by and between Magnatherapy, Inc., a Florida Corporation ("Magnatherapy") on the one hand, and Norfields Corporation., a California Corporation ("Norfields") on the other hand.

WHEREAS, Magnatherapy is the owner of U. S. Design Patent Des. No. 411,356 ("the patent") issued June 22, 1999, naming Roper as an inventor;

Magnatherapy hereby assigns, transfers and sets over unto Norfields, and its successors and assigns, all of its right, title and interest to the patent, including the right to sue infringers for damages as well as injunctive relief.

Magnatherapy represents, warrants and covenants (a) that it is a corporation duly organized, validly existing and in good standing under the laws of the state of its incorporation and has the corporate powers to own its patented assets and intellectual properties and to carry on its business as now being and heretofore conducted; (b) that the execution, delivery and performance of the Agreement have been duly authorized, do not violate its certificate of incorporation by-laws or similar governing instruments or applicable law and do not, and with the passage of time will not, materially conflict with or constitute a breach under any other agreement, judgment or instrument to

which it is a party or by which it is bound; and (c) that this Agreement is a legal, valid and binding obligation of such party, enforceable in accordance with its terms.
